

1. General provisions**2. Airport tax**

- 2.1. For each departing passenger in international and domestic air transport.
 2.2. The taxes for the use of the carrier's airport shall apply, unless otherwise stipulated in the contractual relationship.
 2.3. Airport tax for passengers are calculated from the actual number of departing passengers.
 2.4. Tax for one departing passenger 320,00 CZK

3. Security fee

- 3.1. For each departing passenger in international and domestic air transport.
 3.2. The carrier shall pay the security charge unless the contractual relationship stipulates otherwise.
 3.3. The security fee is calculated according to the actual number of departing passengers.
 3.4. Security fee for one departing passenger 60,00 CZK
